



## MEMORANDUM OF UNDERSTANDING

We, the undersigned organizations, hereby express our intent to engage in a mutually beneficial cooperation in the field of live sciences research to ensure the sustainability of the environment, the conservation and development of forest and wildlife resources. Furthermore, we express the wish to conduct research to establish a sustainable and legal environment, forest and wildlife protection and development system that will benefit the next generation. We strive to achieve that without compromising their right to determine and use the resources by, based on scientific knowledge, monitoring, inspecting and controlling activities that will detect harm and pollution to the environment.

The ANRS Environment, Forest & Wildlife Protection and Development Authority safeguards natural resources through environmental regulation, ESIA oversight, forest and wildlife management, and public awareness. It monitors over 3,000 projects annually and manages protected areas across 4,500+ km<sup>2</sup>. Actively engaged in platforms like IWRM–WASH and partnerships with organizations such as the NCEA and WRI, the Authority shows strong willingness to collaborate with local and international actors. It promotes sustainable development, governance, and job creation through forest royalties and integrated resource initiatives. The Authority is a regional government body in Amhara, Ethiopia which is a proactive regional actor, open to joint research, capacity building, and public-private environmental partnerships.


